### 1.0 BACKGROUND

1.1 I have considered the grounds for exemption of information contained in the report referred to above and make the following recommendations to the Proper Officer.

#### 1.2 Exemptions applying to the report:

12. – Information relating to a particular individual

13. - Information which is likely to reveal the identity of an individual

1.3 **Factors in favour of disclosure:** Transparency of decision making process

#### 1.4 Prejudice which would result if the information were disclosed:

i. Regardless of how the report is worded the identity of the individual concerned would be ascertained.

#### 1.5 My view on the public interest test is as follows:

i. Public interest is best served if the Standards Committee retains the information in order to ensure the protection of the personal interest of the individual concerned.
