Draft Supplementary Planning Guidance: Managing the use of dwellings as holiday homes (second homes and short-term holiday lets)

Eryri National Park Authority has decided to introduce an Article 4 Direction for the Eryri National Park Area which will come into force from the 1<sup>st</sup> of June 2025. The purpose of the Article 4 Direction is to manage the use of houses as second homes and holiday accommodation.

The Supplementary Planning Guidance (SPG) provides guidance on which current planning policies are relevant, how they will be applied and provide further information on how planning applications for changes of use required by the Article 4 Direction will be assessed.

A Welsh Language Impact Assessment has been prepared, which will be modified following the consultation period and prior to the adoption of the final document.

Comments made during this consultation should only cover the content of the draft SPG. It is not an opportunity to revise the Eryri Local Development Plan policies, r to re-consider the decision of introducing the Article 4 Direction.

## Comments will be accepted until 5pm, 14th of April 2025.

Once the Authority has considered the responses received, the Snowdonia National Park Authority will formally approve the guidance and publish them in final form, including any agreed changes. The Supplementary Planning Guidance will then be taken into account as a material consideration when determining planning applications.
